CHAPTER 2 - BIG GAME

#201 - LICENSE FEES

A. Big Game License Fees

1. Nonresident Big Game Licenses

In accordance with the provisions of 33-4-102, CRS, nonresident big game fees for the year 2002 2003 shall be as follows:

01/09/2003 Basis and Purpose Chapter 2 - Big Game **Draft Basis and Purpose Statement:** Non-resident big game licenses are modified to reflect fee indexing for consumer price index changes. The fees for deer, elk, antelope, bear, mountain lion, rocky mountain bighorn sheep, mountain goat, and moose are increased for the second year, in accordance with 2001 statutory changes which required indexing annually based on the consumer price index for the Denver-Boulder area. The CPI for 2002 was 2.158%. The fees were rounded down to the next lowest \$5 increment for administrative convenience, but the absolute value based on the 2001 CPI of 5.4% is used for calculation of the base figure to be used for each annual increase. These base values in 2002 were: \$284.65 for antelope and deer; \$474.42 for bear, elk, and mountain lion; and \$1,581.39 for mountain goat, moose, and Rocky Mountain bighorn sheep. Since there are no nonresident desert bighorn sheep licenses issued, there is no fee shown. Bear and mountain lion fees previously reduced as agreed with the legislature are maintained at that lower level of \$250, to maintain hunter participation in predator management. The nonresident antlerless elk license fee of \$250, which was first reduced in 2002, is maintained for 2003 to for continued encouragement of nonresident participation in Colorado hunting and especially in the achievement of population objectives through antlerless elk harvest. This is again important in 2003 as many herds remain above objective. Drought conditions in 2002 place even further emphasis on the need to achieve population objective through herd reduction.

The primary statutory authority for these regulations is sections 33-1-101, -102 through -108, -110, 33-4-102, Article 6 of Title 33, and 24-4-103, all C.R.S. as amended.

EFFECTIVE DATE - THESE REGULATIONS SHALL BECOME EFFECTIVE MARCH 1, 2003 AND SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL REPEALED, AMENDED OR SUPERSEDED.
